**• Bus check-in 7:45 at the K-Mart parking lot Saturday, September 11<sup>th</sup>, 2010.**

- Performances at Noon and 2:15
- We will have adult chaperones on the bus.

We will leave the Richland County Fair around 5:00 PM and arrive home on or about 6:30 PM.

Parents: arrange to pick up your child(ren) at the **K-Mart parking lot no later than 6:30 PM!!!**

**• HeatWave is asking for a donation of \$5.00 per rider, whether parent or member, to help defray cost of the bus.**

- Members get a free gate pass.
- Parents will need to pay the \$4.00 gate fee.
- **Parents who wish to ride the bus must request a ride on the bus in writing and in advance of departure.**
  - Seats for parents will be on a first-come-first-served basis. **See form below.**

**○ Be sure to eat something before you leave your house or bring a breakfast snack for the bus ride!**

- Do not bring valuables! Bring only enough money for a snack or small lunch at the fair.
- Wear your *HeatWave* T-shirts.
- **Bring ALL parts of both costumes.**
- **Girls hair must be up and completely off face and neck ...similar to the State Fair performances.**

**• You MUST email or call Janet to let her know if you are going.**

- **You MUST bring the permission slip to the bus.**

- **If you are NOT going to Richland Center on the bus, you MUST email Janet ([heatwave@ticon.net](mailto:heatwave@ticon.net)) to let her know if you will be going on your own.**

- **If you are not going at all you do not need to return the permission slip, but you still need to contact Janet to let her know you are not going.**
